PRIVACY POLICY

1. We respect your privacy

- 1.1. The Clifford Wallace Agency Pty Limited respects your right to privacy and is committed to safeguarding the privacy of our customers and website visitors. We adhere to the Australian Privacy Principles contained in the *Privacy Act* 1988 (Cth). This policy sets out how we collect and treat your personal information.

2. Collection of personal information

6. Security of your personal information
